## MHz CREDIT APPLICATION AND AGREEMENT (Page 2)

The undersigned (Applicant) hereby applies for a business credit account with Mega Hertz. The credit is not for personal, house hold or family use. The Applicant will abide by the terms as charged or as set out on any contract, purchase order, invoice, bill of lading or any other documents, all of which are made a part hereof, for any goods, equipment and services delivered by Mega Hertz at the costs of goods, equipment or services and payment will be due in full within thirty (30) days of delivery of goods, equipment or services by Mega Hertz unless otherwise agreed to in writing. By this document (The "Agreement") Mega Hertz is entitled to obtain credit information from the reference listed above.

In all purchases, under the account created by this application, as described in the Applicant's Purchase order and/or MHz shipping documents, the Applicant grants to Mega Hertz a security interest, until such time as the Applicant fulfills its' obligation to MHz for payment of all goods, equipment and/or merchandise purchased and delivered by MHz.

The Signatory here to warrants that he or she and the person(s) listed above have the authority to obligate the Applicant by purchasing goods, equipment and services from Mega Hertz, and that he or she has the authority to bind the company to this Agreement. The Applicant shall be responsible for payment of all sales and use taxes and shall indemnify and hold harmless Mega Hertz from any loss, cost, or expense Mega Hertz may incur, including attorney fees and court costs, in the event the Applicant fails to pay such taxes.

**The Signatory acknowledges that this Agreement is being prepared for the purpose of receiving goods, equipment or services on credit from Mega Hertz and that the anticipated extension of credit will not be more than \$\_\_\_\_\_.** The Signatory warrants that he or she has personal knowledge of the financial condition of the Applicant and represents that the Applicant is in good financial condition, will be able to pay Mega Hertz in the amount of the credit limit, and will so pay within thirty (30) days of delivery of the goods, equipment or services.

In the event of a breach of this agreement, including bankruptcy, assignment for the benefit of creditors or nonpayment, Mega Hertz shall be entitled to recover all cost of collection, interest, principal and reasonable attorneys' fees. In the event of failure of timely payment Mega Hertz shall be entitled to receive interest on the past due amount at the annual rate of eighteen (18%) percent in addition to the principal balance.

The place of performance and transaction of business shall be deemed to be in the County of Arapahoe, State of Colorado, and in the event of litigation, the Applicant consents to in personam jurisdiction of the Colorado courts, County of Arapahoe, State of Colorado.

Should any of the provisions of this Agreement be deemed by a court of competent jurisdiction to be void, voidable or unenforceable, only that provision shall be affected thereby and all other provisions shall remain fully enforceable.
